# CONFIDENTIAL DECLARATION AND CERTIFICATION OF FINANCES OF INTERNATIONAL UNDERGRADUATE APPLICANTS

This purpose of this form is to certify that you will have the estimated sum of \$72,200 for your first year of study at WPI, not including travel expenses. You should also indicate how you will meet your expenses for subsequent years of study. A Certificate of Eligibility (Form I-20) for a Student (F1) visa will not be issued unless this form is completed and the necessary certifications are obtained. Please note that you will be required to show proof of adequate funding to US Consular officials when applying for a visa.

Please note that students holding the Student (F1) visa will be extremely limited in their options to work. Therefore, the applicant should not look to employment, either part-time during the academic year or full-time during the summer, as a guaranteed means of support while at WPI. Under no circumstances are students permitted to work full-time during the academic year. Additionally, the cost of attendance at WPI will likely increase each academic year, while scholarships will not.
