This data is a Wellness Day, but it was the only available day that could be booked. Event is open to all of campus. Ticketed event. 50 tickets are reserved for non-WPI guests. Ticket prices: $\$ 5$ for WPI guest; $\$ 7$ for non WPI guest.
Requesting for funds to cover additional costs for LNL, décor, food, campus police, gift cards, printing, photo booth, DJ and lighting. Since the event is on a Wellness Day, the sound and lighting will be sourced from an external DJ and not LNL because LNL does not operate on Wellness Days. The quote for the DJ's lighting and sound package is around $\$ 3,000$.
Some LNL members will be volunteering at the event for additional support. Funds will also be used to pay for their service.
Total Requested Amount: \$5310.00
